ORDER:

In the G.O 1st read above, Government have issued comprehensive guidelines for implementation of Self Employment Schemes in all the Welfare Departments for 2013 - 2014.

2. In the G.O 2nd read above, the subsidy pattern for the Self Employment / Economic Support Schemes implemented by the Minorities Welfare Department is as follows:-

UNIT COST	SUBSIDY
Unit Cost Up to Rs.1,00,000/-	80%
Unit Cost Rs.1,00,000/- to Rs.2,00,000/-	70%
Unit Cost Rs.2,00,000/- to Rs.10,00,000/-	60% or Limited to Rs. 5.00 lakhs

3. Government after careful examination of the matter and in continuation of orders issued in the references 1st and 2nd read above hereby order to modify the subsidy pattern of the Self Employment/ Economic Support Scheme to the Minority beneficiaries from 2018-19 onwards is as follows and all the applications that were received in the financial year 2015-16 through OBMMS, but which are pending can be considered afresh in this financial year in this pattern:-

Self Employment / Economic Support Scheme	Up to Rs.50,000/-	100%	Nil
	Rs.50,001/- to Rs.1,00,000/-	80%	Balance as bank loan or beneficiary contribution
	Rs.1,00,001/- to Rs.2,00,000/-	70%	Balance as bank loan
	Rs.2,00,001/- to Rs.10,00,000/-	60% or Limited to Rs. 5.00 lakhs.	

4. The Vice Chairman & Managing Director, Telangana State Minorities Finance Corporation, Hyderabad and The Managing Director, Telangana State Christian (Minorities) Finance Corporation, Hyderabad shall take necessary further action accordingly.

5. The Centre for Good Governance shall ensure that all the above eligible criteria are incorporated in the online beneficiaries Management and Monitoring System.
