ORDER:-

In the G.O. 1st read above, the erstwhile Government of Andhra Pradesh have issued comprehensive guidelines for implementation of Self Employment Schemes in all the Welfare Departments for 2013 -2014.

2. In the G.O. 2nd read above, orders were issued revising the guidelines for implementation of various Self Employment Schemes being implemented by the Minorities Welfare Department.

3. In the reference 3rd read above, the group of Ministers on Welfare with Ministers (Finance, BC Welfare and Tribal Welfare) under the Chairmanship of Deputy Chief Minister (Education) Telangana State have made the recommendations in regard to Self Employment Schemes being implemented by Minorities Welfare Department as follows:-

Sl.No.	Criteria	Earlier	Proposed
1.	Subsidy: For other BC / Minority	50% the unit cost limited to Rs.1.00 Lakhs	Unit cost of Rs.1.00 lakhs: Subsidy 80% Unit cost of Rs.1.00 - 2.00 lakhs : Subsidy 70% Unit cost above Rs.2.00 lakhs: Subsidy 60%, limited to Rs.5.00 Lakhs balance is bank loan.

4. Government after careful examination of the matter hereby order that the guidelines issued in the reference 2nd read above, shall be followed 2015-2016 onwards also for implementation of Self Employment / Economic Support Scheme being implemented by Minorities Welfare Department subject to the following modification.

Unit cost Rs.1,00,000 to Rs.2,00,000/-	70%

ORDER:

Government of Telangana is taking steps for the Socio Economic & Educational amelioration of Minorities through various innovative schemes. Bank linked subsidy cum loan scheme is one of the initiatives for self employment of Minority youth. It is seen that number of educated unemployed Minority youth are engaged in plying Autos in the GHMC limits, majority of them taken on rent from owners and eke out a paltry livelihood.

2. Government after careful examination of the situation decided to introduce the "Own Your Auto Scheme" and accordingly Government in Transport Department issued G.O.Ms.36 Transport, Roads & Buildings (Tr.I) Department, dated:04.09.2015 sanctioning of 1000 Autos for the Minority Youth to Ply within the limits of GHMC. These will be small three wheeler with three seating capacity Auto Rickshaws run on Liquid Petroleum Gas (LPG)/ Compressed Natural Gas (CNG).

3. Vice Chairman & Managing Director, Telangana State Minorities Finance Corporation is requested to issue a notification inviting applications from the eligible Minority youth with the following eligibility criteria.

1. Eligibility Criteria:

- a) The Applicants shall be natives of Telangana State
- b) Resident of GHMC area only.
- c) The Applicant shall belong to Minority Communities.
- d) Applicant shall possess a valid three Wheeler Driving License.
- e) The Applicant should not be already in possession of Auto Rickshaw Permit.
- f) The age limit of the applicant shall be between 21 to 55 years as on 1st September, 2015
- g) The Annual income of the applicant shall not exceed Rs 2,00,000/-

2. Procedure for application and processing:

- a). Applicants shall apply online by accessing the website at the following site:

- b). Certificates / Documents to be Submitted:
 1. Adhaar card of the Applicant
 2. Valid Three Wheeler Driving License.
 3. Income certificate issued by the concerned Tahsildar
 4. Xerox Copy of the first page of Bank Pass Book (Savings Account) containing the photos of the applicant.
 5. Present Residential Address Proof (Adhaar card/Voter ID/Ration card/Bank account address.
 6. Two Passport size photos of the Applicant.

4. The Managing Director Telangana State Minorities Finance Corporation shall ensure that necessary software is enabled on the e-pass website at <http://epasswebsite.cgg.gov.in> and Mee Seva centers to ensure applications under the Scheme. All the Applications/Testimonial/Documents shall be made/uploaded online. Afterwards Hard copies of Application and enclosures shall be submitted to Executive Director, Hyderabad/ Ranga Reddy Branch, Office of the Minorities Finance Corporation.
5. Applicants shall be given a time of 20 days for applying and the Empowered Committee consisting of Director, Minorities Welfare, Vice Chairman & Managing Director, Telangana State Minorities Finance Corporation, Special Officer, Telangana State Haj Committee and Joint Transport Commissioner(JTC), Hyderabad shall finalize/shortlist eligible applications and forward the same to Transport Department for issue of permits. Each Applicant will be eligible for 50% subsidy of the cost of the Auto, balance to be Bank loan.
6. The expenditure shall be debited from the budget of 2015 –16 released in the Bankable Subsidy Scheme.
7. Similarly Vice Chairman & Managing Director, TSMFC to get in touch with reputed Auto Manufacturing Companies and Banks for the purchase of Auto Rikshaws and the loan component at the most competitive terms.
8. The whole operation shall be completed within (3) months.
9. The Managing Director, Telangana Minorities Finance Corporation is requested to take necessary action as above duly giving wide publicity and confirm action taken.
